- ✓ To promote research & development and allied services.



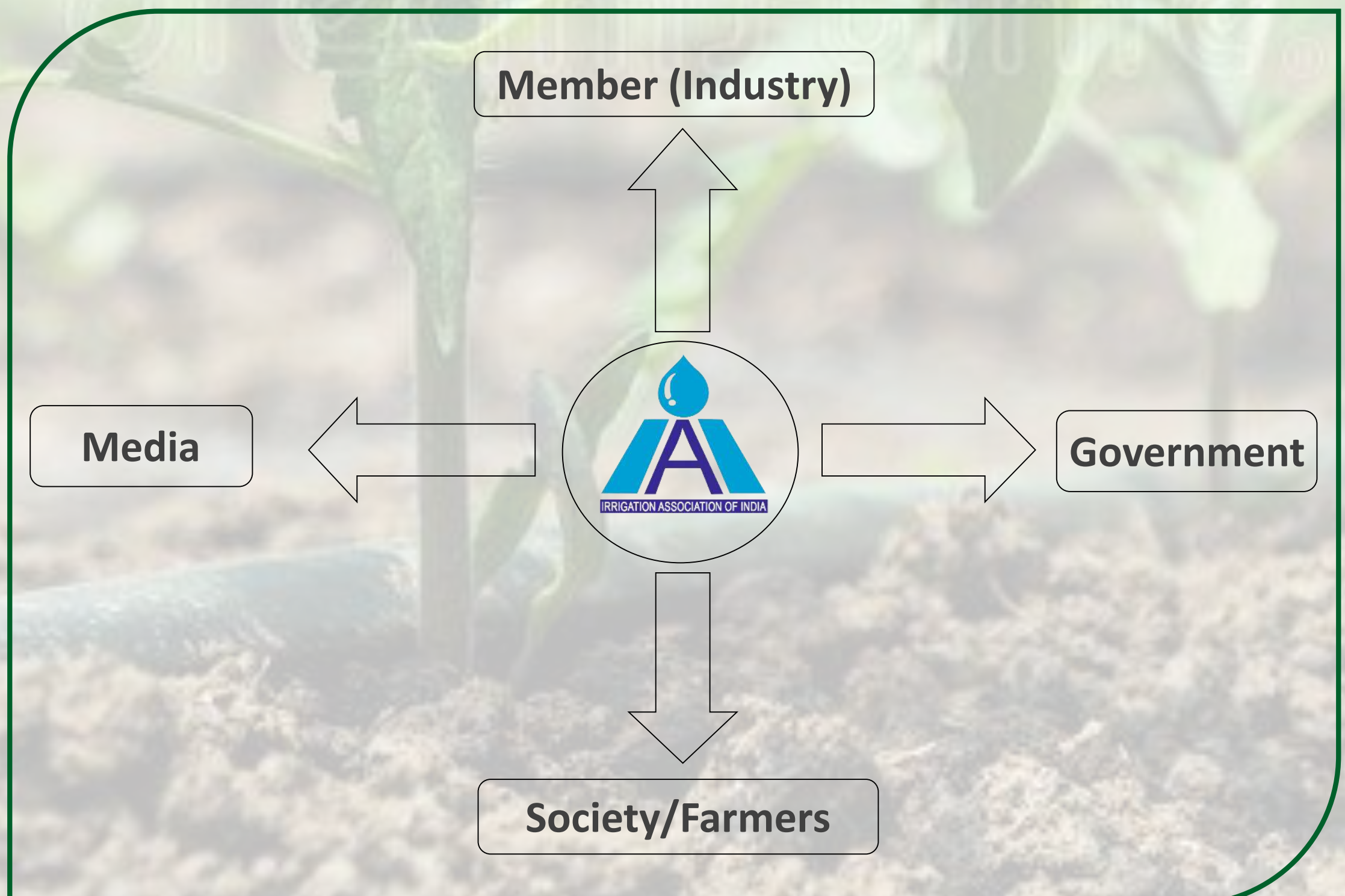

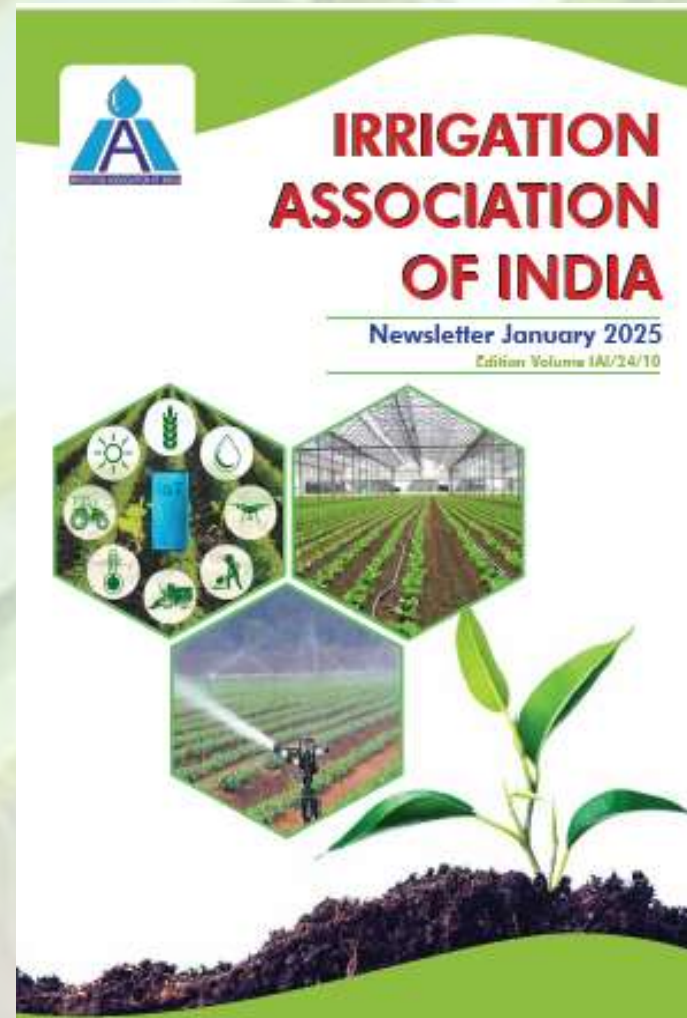

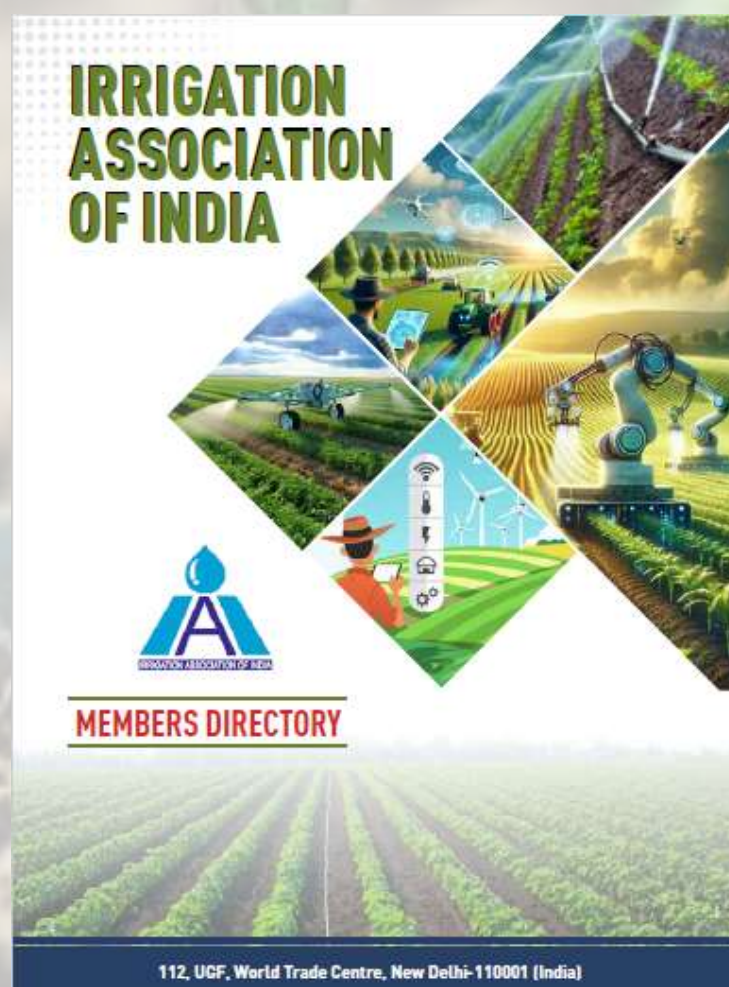

2017

- 5 Years Registration, Spacing as per NMMI
- Pricing : NMMI + 15%
- 7 Years Gap to obtain second subsidy and other operating improvements.

2021

- IAI was part of the committee & engaged EY as a knowledge partner
- Standardizing price revision based on a mutually agreed formula.
- Several technical & commercial updations
- Inclusion of new close spacing BOQ

2022

- Committee constituted for further revision in PDMC scheme
- IAI has represented for price revision as per the formula amongst several other points
- Represented for initiating standard procedure for 6 monthly price revision

Policy advocacy resulted in continuous revisions in *PDMC guidelines* of Govt. of India for the benefit of MI industry

2022

- Recommended formula for Standardized Price Revision of Micro Irrigation Systems (MIS) in all states under the PDMC Scheme.
- Recommended the inclusion of new Close Spacing in Bill of Quantities (BoQ)

2023

- MoA&FW introduces new Operational Guidelines for the PDMC Scheme in 2023
- BIS Standardization Cell established at IAI
- Collaboration with central, state governments and irrigation companies to promote advanced data-driven automations in micro-irrigation

2024

- Project Management Unit (PMU) established in partnership with FICCI and Ernst and Young (EY) under the PDMC Scheme
- Integrated Training Programme and Entrepreneurship Fair conducted for Micro Irrigation Technicians under skill building initiatives in collaboration with Govt. of Uttar Pradesh

Policy Advocacy



- GST: Successfully restored GST on Micro-Irrigation at 12% through various representations in partnership with our tax advisors, EY
- Andhra Pradesh: Release of payment to industry after 2 years in March 2022
- Telangana: Price revision issued in March 2022
- Gujarat: Received assurance from Hon'ble CM for immediate action on pricing, increased budget & revised operating guidelines in Feb 2022
- Tamil Nadu: IAI is part of the pricing committee formed by the government in Mar 2022. Price revision expected any moment
- Ministry of Agriculture: Several meetings held with Directors/JS/AS/Secretary including recently CEOs meeting with OSD and Secretary-Elect for streamlining of PDMC implementation.

- **turnover above ₹ 20 Crore upto ₹ 50 Cr.**

Prime Membership

Silver Category Prime Member

- Person, Firm, or Company engaged in manufacturing of complete range of micro irrigation systems including related services
- **turnover above ₹ 50 Crore upto ₹ 100 Crore**

Gold Category Prime Member

- Person, Firm, or Company engaged in manufacturing of complete range of micro irrigation systems including related services
- **turnover above ₹ 100 Crore upto ₹ 200 Crore**

Platinum Category Prime Member

- Person, Firm, or Company engaged in manufacturing of complete range of micro irrigation systems including related services

- Person, firm or company other than one qualifying for regular membership
- Firm or company engaged in manufacturing of only components or in the business of serving the industry as **suppliers** of raw materials, consultancy with respect to policies, engineering designing, layout, usage or application of irrigation, drainage erosion control equipment

Honorary Membership

Honorary Member

- Not to exceed two in any year
- Any person upon an affirmative vote of the majority of the members as per the rules of association
- The limitation of two positions in a year can be relaxed or shall not apply for willing past presidents of IAI, retired or no longer actively employed in the industry

Technical Membership

Technical Member

- Individual from academia, Government officials engaged in the research in Irrigation, interested in engineering design, Layout, use or application of Irrigation equipment.
- Membership and duration to be approved as per association rules

International Subscribing Membership

International Member

- Firm or company outside India engaged in the manufacturing and sale of Irrigation, Drainage and erosion control equipment.
- Such firms/ companies irrespective of whether they sell their component in India or not, as per association rules

- Association or society, functioning in India or Abroad to promote the interest of the Irrigation Industry on a local level
- Membership and duration to be approved as per association rules
